Waiver and Release Form

The Veterans Memorial Recreational Center has policies and procedures in place that will be outlined here. Please read the following information carefully.

Use of the VMRC after standard operating hours is strictly for those who have purchased a 24-Hour membership. Standard members who have not purchased 24-hour access are prohibited from entering the facility after standard operating hours. As a 24-hour access member you will be given a fob to access the building after standard operating hours. The additional rules to this are as follows:

- Mandatory \$20 fee for the access fob (Replacement Fob Fee: \$20)
- Only one 24-hour member (18+) may enter the front door at a time during non-staff hours
- Only active account members will be permitted entry
- Fob sharing is strictly prohibited and will result in a termination of membership

The VMRC reserves the right to cancel the membership of any member whose actions are determined to be detrimental to the use, safety, and enjoyment of the facility. **Initials** _____

Understand that you are purchasing a membership that does allow you access 24/7 and as such, there will be no supervision or assistance except during staffed hours. Staffed hours may change at the discretion of the VMRC and Garner Parks and Recreation Department. Surveillance cameras are equipped but are not monitored continuously; help will not be available during non-staffed hours. A first-aid station, AED are located at the front of the building. The VMRC is equipped with emergency alarms that, when activated will alert emergency services and unlock the front door and locker rooms.

The VMRC and City of Garner Parks and Recreation Department highly encourages all 24-hour members to find an adult workout partner who has also purchased a 24-hour access membership, when using the facility during non-staffed hours. **Initials** _____

Because physical exercise can be strenuous and subject to risk of serious injury, the VMRC and Garner Parks and Recreation Department urges you to obtain a physical examination from a doctor before using any exercise equipment or participating in any exercise activity. You agree that you are voluntarily participating in the use of the facility and assume all risks of injury, illness, or death. Waiver and Release

It is always advisable, especially if the participant is pregnant, suffers from an underlying medical condition, take medication, smokes, vapes, has a family condition of coronary disease, or has recently suffered an illness, injury or impairment to consult a physician before undertaking any fitness center activity.

Warning of Risk

Aerobic and other fitness activities such as passive/resistive weight training, jogging, free weights, and other training devices are intended to challenge the physical, mental, and emotional resources of the participant. Despite careful and proper preparation, instruction, medical advice, conditioning, and equipment, there is still a risk of serious injury. All hazards and dangers cannot be foreseen. Depending on the particular activity, certain risks, dangers and injuries due to overexertion, improper technique, ignoring safety precautions, failing to follow instructions, slips and falls, unfamiliarity with the equipment and/or exercise, equipment failure, failure in supervision/instruction, premises defects and other risks inherent to the particular activity exist, in this regard, it is impossible for the City of Garner to guarantee absolute safety.

Dependent upon the person's physical condition, age, and/or skill level, aerobics and fitness classes can involve a substantial risk of the following types of injuries. This list is by no means complete, but includes some of the more common elements:

1. Heart Attack, stroke, and circulatory problems
2. Bone and joint injuries
3. Back and neck injuries
4. Shin Splints
5. Muscle strain and other muscle injuries
6. Foot injuries or problems

Waiver and Release of all claims and assumption of risk

Please read this for carefully and be aware that in signing up and participating in any program/activity/membership, you will be expressly assuming the risk and legal liability and waiving and release all claims for injuries, damages, or loss which you and/or your family might sustain as a result of participating in any and all activities connected with and association with the program/activity/membership.

I release any and all claims for liability which may arise. I understand that injuries may occur and that the City of Garner; the Garner Parks and Recreation Department; the Veteran's Memorial Recreation Center and Garner Aquatic Center, and any employees and volunteers are not responsible for these injuries, whether through their negligence or otherwise. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in this program/activity/membership against the City of Garner, the Garner Parks and Recreation Department; and the Veterans Memorial Recreation Center and Garner Aquatic Center, including its officials, agents, volunteers, and employees.



VMRC Membership Definitions

Family: A family is considered no more than two adults, romantically involved, residing in the SAME household and all dependents living in that household, with exceptions for nannies and college age students under the age of 23. Foster parents and/or legal guardians caring for the children in place of their parents will be considered parents for the purpose of this membership.

Couple: Two adults, romantically involved, residing in the SAME household. No additional members may be added.

Individual: An individual 18-23 years of age who is not a full-time student, or an individual 24-64 years of age. No additional members may be added.

Senior Couple: Two adults, romantically involved, BOTH 65 years of age or older residing in the SAME household. No additional members may be added.

Senior Individual: Must be 65 years of age or older. No additional members can be added.

Student: Any individual age 7-23 years of age. Members 18-23 years of age must be full-time students and must show proof of enrollment. No additional members may be added.

I have read and fully understand the Veterans Memorial Recreation Center and Garner Aquatic Center Waiver and Release Information, warning of risk, assumption of risk and release of all claims. I and everyone on my membership agree to the terms stated in this contract regarding membership policies and procedures.
